For me a house is a home, and being part of a community, and having a home is one of the most important things in a person's life. Unfortunately, the UK, and particularly London, has quite a dysfunctional attitude to housing, leaving many struggling to find a home. I think that it is a critical time for new approaches to the housing crisis in London and I see Community Land Trusts as an exciting way forward. I would therefore be really honoured to be involved in what is an exciting community-led project with a big vision. Apart from my enthusiasm for the organisation and what it hopes to achieve, I can also bring over 10 years of experience working in the policy and public affairs environment to the role. In those 10 years I have worked amongst other things on housing related policy, with one of my proudest moments in my campaigning career being a U-turn by Government regarding funding for supported housing.
